#### READING OF THE MINUTES:

The Minutes of the August 11, 2014 Council Meeting were approved on a Motion by Mr. McGowan. Second by Ms. Lilly-Kemmerer. Council unanimously approved Minutes of the August 11, 2014 Council meeting.

#### PRESENTATION OF MATTERS BY RESIDENTS AND TAXPAYERS:

- 1. Daniel Redington, Director of the Mary Meuser Library was present to inform Council that the mold remediation project in the Children's department has been completed. The Children's Department is now open. Mr. Drake added that the contractor, Air Care and Restoration did an outstanding job. Mr. Redington will send a letter of thanks.
- 2. An Easton resident, Ms. Eagle spoke to praise a Borough Employee. Her thirteen year old grandson had been at Meuser Park and lost his cell phone. The family checked all around to find it. Jeff Lewert of the Public Works Department found the phone, charged it and contacted the owners to see that the phone was returned. Ms. Eagle asked that Council recognize Jeff as a good honest and caring employee.

#### COMMUNICATIONS BY THE MAYOR:

- Mayor Perruso asked Council to approve a handicap parking spot at 1542 Spring Garden Street. Motion by Ms. Lilly-Kemmerer to allow a handicap parking spot at 1542 Spring Garden Street. Second by Mr. Larimer. Council unanimously voted to allow a handicap parking spot at 1542 Spring Garden Street.
- 2. The Mayor asked Chief Parkansky how the new traffic pattern at the Wilson Elementary School went. Mr. Parkansky said it went well and although there was some confusion in the afternoon, it is much safer for the children.
- 3. Chief Parkansky noted there are currently three vacant crossing guard positions. Danielle Reese of 1532 Lehigh Street has applied for one and Mr. Parkansky asked Council to approve her hiring pending a criminal history check. Motion by Mr. Lipari to hire Ms. Reese as a crossing guard pending proper background checks. Second by Mr. Starniri. Council unanimously approved the hiring of Ms. Reese pending checks.

# COMMUNICATIONS FROM THE BOROUGH MANAGER:

1. Ms. Garcia read a letter to Council from the Wilson Area High School/Mr. Wagner. WAHS asked permission to change Warrior Lane to one direction only from 2:30 to 3:00 pm on days school is in session. Chief Parkansky agreed this makes the area safer for the kids. Motion by Mr. Lipari to allow WAHS to change the traffic pattern for a half hour on days school is in session. Second by Mr. Starniri. Council unanimously approved changing Warrior Lane to one direction for ½ hour on school days. Ms. Garcia was asked to draft a letter giving the

- school permission to make the change and also request that the school district employee assisting with traffic wear a safety vest.
- 2. Ms. Garcia read a letter from the owner of Stage Door Studio, Patricia Bartholomew. She requested that the borough make the north side of Washington Blvd. in the 1700 block angled parking. She has brought this request to council once before and it was denied. Chief Parkansky explained the dimensions necessary to legally change to angled parking. This block does not meet those requirements. The south side is grandfathered.
- 3. Ms. Garcia asked Council who would be attending the PSAB fall conference. Mayor Perruso and Mr. McGowan will be attending.

- 4. Mr. Drake talked about the ongoing issues with the plans for the suppression system at Fisk Field. A letter was sent and lost. The plans have now been delivered to Arnie Cohen at Code Master and the process will continue.
