The Reorganization Meeting of the Council of the Borough of Wilson was held in the Guy B. Tomaino Public Safety Building at 2040 Hay Terrace, Easton, PA. Mayor Perruso called the meeting to order at 6:00 pm.

Also present were: Mayor David S. Perruso, Solicitor Stanley Margle and Director of Public Works Gregory Drake.

Mayor Perruso received Certificate of Election and Affidavit of Residency forms from Mr. Lipari, Mr. McGowan, Ms. Taylor, Mr. Verenna, Mr. Schaffer and Mr. Palinkas.

Mayor David Perruso performed the swearing in of Russell Lipari, James McGowan, Pamela Taylor, Tony Verenna, Daniel Schaffer and Scott Palinkas.

Mr. Starniri nominated Mr. Feinberg for Council President. Mr. Palinkas nominated Mr. Verenna for Council President. Votes as follows: for Mr. Feinberg – Mr. McGowan, Mr. Starniri, Ms. Taylor and Mr. Feinberg (4); for Mr. Verenna – Mr. Lipari, Mr. Palinkas, Mr. Jones, Mr. Schaffer and Mr. Verenna (5). Mr. Verenna was elected Council President.

Mr. Verenna nominated Mr. Lipari for Council Vice-President. Ms. Taylor nominated Mr. Starniri for Council Vice-President. Votes as follows: for Mr. Lipari– Mr. Verenna, Mr. Palinkas, Mr. Jones and Mr. Lipari (4); for Mr. Starniri – Mr. Feinberg, Mr. McGowan, Ms. Taylor, Mr. Schaffer and Mr. Starniri (5). Mr. Starniri was elected Council Vice President.

Mr. Starniri nominated Ms. Taylor as President Pro-Tem. Ms. Taylor was elected President Pro-Tem by a unanimous vote of Council.

Mr. Feinberg made a motion to appoint Shannon Duelle Heckman as Vacancy Board Chairman. Second by Mr. Lipari. Council concurred.

Mr. Feinberg made a Motion to appoint Stanley Margle to serve as Borough Solicitor. Second by Mr. Lipari. Council unanimously agreed.

Mr. Feinberg made a Motion to appoint T&M Associates to serve as Borough Engineer. Second by Mr. Starniri. Council unanimously agreed.

Mr. Starniri made a Motion to appoint David Kunsman and Company to serve as Borough Auditor. Second by Mr. Lipari. Council concurred.

Mr. Verenna appointed Mr. McGowan as the Representative for MECAB and Mr. Palinkas as the alternate.

Committees will be addressed at the January 11, 2016 Council meeting.

Mr. Verenna made a Motion to adjourn the meeting at 6:10 p.m. Second by Mr. Lipari. Council concurred.
