COMMUNICATIONS FROM THE COUNCIL PRESIDENT:

Motion by Ms. Gable to nominate Mr. Bracken for Council President Pro-Tem. Second by Mr. Wacik. With no other nominations being heard, motion by Mr. Wacik to close nominations. Second by Ms. Gable. A roll call vote followed. Yes votes cast by Ms. Allen, Mr. Burke, Mr. Figueroa, Ms. Gable, Ms. Muzac, and Mr. Wacik. Mr. Bracken abstained. Motion passed with a 6-0-1 vote.

Mr. Burke noted that the last concert for the Meuser Park Summer Concert Series was held over the past weekend. He requested that Council look into solving parking issues that frequently occur during the concerts. Barricades and direction signs were discussed.

Chief Meehan stated that one open spot for a Police Officer remains. The Civil Service list has been exhausted by the recent three new hires. He requested Council's permission to start the Civil Service Testing for Police Officers. Motion by Ms. Gable to approve. Second by Mr. Wacik. A roll call vote followed. Yes votes cast by Ms. Allen, Mr. Bracken, Mr. Burke, Mr. Figueroa, Ms. Gable, Mr. Lipari, Ms. Muzac, and Mr. Wacik. Motion passed with an 8-0 vote.

FIRE:

Ms. Gable asked Chief Sipel how many applications were received for the open full-time Fire Fighter spot. Chief Sipel stated that he has received eight.

Mr. Flowers reported on the progress of the Pickleball/Tennis Court project. The base has been put down. People have been driving on the new base. Public works will attempt to fence the area off in some manner.

ATTORNEY:

Solicitor Margle reported on the pending purchase of property at 350 Balata Street. He has been in communication with the owner's attorney to finalize outstanding issues. Closing is estimated for the end of September.

Mr. Margle advised that Wilson Borough and the Wilson Area School District have both approved the Dixie TIF. Northampton County IDA and GPA have been meeting and will continue to meet. Northampton County will also hold a hearing on the TIF. Construction is anticipated to be at the close of the construction loan; approximately February 2024. Motion by Mr. Wacik to have Solicitor Margle attend all Dixie related meetings with Northampton County. Second by Mr. Bracken. A roll call vote followed. Yes votes cast by Ms. Allen, Mr. Bracken, Mr. Burke, Mr. Figueroa, Ms. Gable, Mr. Lipari, Ms. Muzac, and Mr. Wacik. Motion passed with an 8-0 vote.

Solicitor Margle reported that Safavieh will be coming before Council and Zoning regarding the property at 1991 Northampton Street. They will be looking to redesign the current warehouse. It is anticipated Safavieh will request to have North 20th Street turned over to them along with an amendment to the Wilson Borough zoning map. The Lehigh Valley Planning Commission, Wilson Borough Council, and Wilson Borough Zoning Hearing Board will be reviewing, along with others.
