The Biennial Reorganization Meeting of the Council of The Borough of Wilson was held in the Guy B. Tomaino Public Safety Building at 2040 Hay Terrace, Easton, PA. Mayor Donald Barrett called the meeting to order at 6:00 p.m.

Solicitor Margle reviewed proper procedures for the reorganization meeting.

Mayor Barrett performed the swearing in of Mr. Scott Palinkas and Ms. Kimberlee Muzac. Mr. Jeffrey Bracken, Mr. Russell Lipari and Ms. Susan Allen were sworn in by notary on a previous date.

Roll Call was taken.

Nominations were taken for Council President. Ms. Gable nominated Mr. Burke. Mr. Lipari nominated himself.

Roll call vote for Mr. Burke: Yes votes cast by Ms. Allen, Mr. Bracken, Ms. Gable, Mr. Palinkas, Ms. Muzac and Mr. Woodring. No votes cast by Mr. Lipari. Mr. Burke abstained. Vote was 6-1-1

Mr. Burke took the seat of Council President. Mayor Barrett handed the gavel to Mr. Burke.

Nominations for Council Vice President were taken. Mr. Lipari nominated himself and Ms. Gable nominated Mr. Woodring.

Roll call vote for Mr. Lipari: Yes votes cast by Mr. Bracken, Mr. Burke, Mr. Lipari, Mr. Palinkas, and Ms. Muzac. No votes cast by Ms. Allen, Ms. Gable and Mr. Woodring. Vote was 5-3.

Mr. Lipari took the seat of Vice President.

Nominations for Council President Pro tem were taken. Mr. Lipari nominated Mr. Bracken and Ms. Gable nominated Mr. Woodring.

Roll call vote for Mr. Bracken: Yes votes were cast by Ms. Allen and Mr. Lipari. No votes cast by Mr. Burke, Ms. Gable, Mr. Palinkas, Ms. Muzac and Mr. Woodring. Mr. Bracken abstained. Vote was 2-5-1.

Roll call vote for Mr. Woodring: Yes votes were cast by Mr. Burke, Ms. Gable, Mr. Palinkas and Ms. Muzac. No votes were cast by Ms. Allen, Mr. Bracken, and Mr. Lipari. Mr. Woodring abstained. Vote was 4-3-1

Mr. Woodring took the seat of Council President Pro tem.

Mr. Lipari made a motion to adjourn at 6:15 pm. Second by Mr. Woodring and Council concurred.
